ADVOCACY ALERT: PROTECT OUR KIDS ACT

Following the release of the Government Accountability Office's Report, "Child Fatalities from Maltreatment: National Data Could Be Strengthened," child welfare advocates began working to enact new legislation to paint a more accurate picture of current child abuse and neglect rates. This effort evolved into the **Protect Our Kids Act**, which Senators Kerry and Collins introduced in the Senate and Representatives Doggett and Crowley introduced in the House in December of 2011. Some of the primary goals of the law are ensuring quality reporting and disclosure of child abuse and neglect statistics across all states. (Fact Sheet)

Last month the Children's Advocacy Institute, First Star, and the University of San Diego School of Law collaborated to release a follow-up report, "State Secrecy and Child Deaths in the U.S.," which ranks child death and near death reporting on a state-by-state basis. The report further emphasizes the need for reform of child abuse death reporting and the importance of legislation such as the Protect Our Kids Act.
