When Home is Where the Hurt Is: An Exploration of Family Facilitated CSEC

Commercial Sexual Exploitation of Children (CSEC): Sexual activity involving a child in exchange for something of value or promise thereof, to the child or another person. In this situation, the child is being treated as a commercial sexual object.

Family Facilitated CSEC: Occurs when a family member exchanges sexual acts with a child for goods, substances, rent, services, money, or status within the community. Family members can include parents, aunts, uncles, cousins, grandparents, etc.





Statistics



According to the U.S. Department of Justice, 34% of child sexual abuse is inflicted by a family member.



The U.S. National Human Trafficking Hotline estimates that a familial relationship is the second most common form of induction into commercial sex.
